## Oak Valley College Policy on Student Use of Generative Al Tools

The purpose of this policy is to establish guidelines for the use of artificial intelligence (AI) tools in courses at Oak Valley College. This policy is intended to promote academic integrity and ensure that all students have a fair opportunity to succeed in their studies.

Professors have the authority to implement a policy different from this one that meets the needs of their course, but the school's general policy is as follows:

### 1. Grammarly

Unless specifically disallowed by your professor, students are permitted to use the free version of Grammarly to edit their original written work for misspellings and grammatical errors and to improve clarity, style, and tone.

### 2. Chat GPT, Bard, and Other Generative Al Tools

Oak Valley College understands the immense value of generative AI tools in the business world today. Accordingly, we want to encourage students to utilize them so as to become familiar with their potential applications in the workplace.

Professors are encouraged to find creative and proper ways to integrate the usage of AI tools into their courses. Because the purpose of assignments is to facilitate and measure learning, however, students must utilize AI tools appropriately for assistance rather than as a means of sidestepping the critical thinking, analysis, and diligent study that are a part of college-level coursework. Unless otherwise required by your professor:

- Students may use AI tools for the following purposes:
  - Brainstorming ideas
  - Generating outlines
  - Revising writing
- Students are prohibited from using AI tools in the following manner:
  - Completing assignments with limited or no original input
  - Generating or modifying existing content to avoid plagiarism detection
  - Submitting AI generated work as their own without citation
  - Violating the college's academic integrity policy in any way
- Students must cite Al generated content:
  - Oak Valley College requires students to cite AI generated content in accordance with The American Psychological Association's (APA) guidelines located at: <a href="https://apastyle.apa.org/blog/how-to-cite-chatapt">https://apastyle.apa.org/blog/how-to-cite-chatapt</a>.



## 3. Enforcement of the Policy

Students are expected to abide by the parameters outlined in this policy. Violations of the rules herein will be treated as violations of the Academic Honesty Policy. Initial offenses may result in academic penalties including grade reduction. Repeated offenses may result in failing a course, academic probation, suspension, or expulsion.

Due to the evolving nature of generative AI technology, Oak Valley College may update this policy over time in light of new information. We will communicate any changes to this policy to the student body prior to their implementation
